

# WARRANTY CONDITIONS

### LEXAN™ THERMOCLEAR™ EASY CLEAN Multiwall Sheet

#### THREE (3) YEAR LIMITED WRITTEN WARRANTY

LEXAN THERMOCLEAR EASY CLEAN sheet will keep its self-cleaning properties as defined herein, within three (3) years of date of sale by SABIC.

### This limited written warranty is subject to the following conditions:

- This limited warranty applies solely to standard sheets produced by SABIC in Europe with a minimum gauge of 6 mm in the colors standard clear (112), opal white (WH7A092X) and standard bronze (515055), used correctly as sloped, vertical or cold curved glazing, handled, stored, processed, installed and maintained according to SABIC' recommendations contained in the Technical Manual. In all cases, the surface bearing the proprietary UV protection must be the only side exposted to direct sunlight and the effects of wheather. The Easy Clean coated side must be facing the outside in order to be in contact with the rain.
- 2. This limited written warranty does not apply to sheet that has been thermoformed, scratched, abraded or exposed to corrosive materials or chemicals.
- 3. This limited written warranty is given only to the original purchaser of SABIC sheet and does not extend to any subsequent purchaser or transferee. Any warranty claim hereunder must be made immediately within the warranty period by specifying the claim in writing and submitting to SABIC the original sales receipt, which must contain the name and address of the purchaser, the date of purchase, the complete product name, the lot number and the volume purchased. On request of SABIC claimant must allow the material to be inspected on site and/or return the sheet to SABIC for testing.
- 4. For the purpose of this limited written warranty: Easy Clean properties will be determined by subjecting a cleaned sheet sample to contact angle measure similar to the test method defined in ASTM D5725-99. An average contact angle will be defined by measuring contact angle obtained by three (3) drop measures at a distance equivalent to a length between rips on the surface of the sample which has Easy Clean properties. For the purpose of this test, liquid used is distillated water. Droplets must have a volume of 1,5µl

- and be delivered at 100 µl/min with a height of 1mm. Any claims for sheets having an average contact angle higher than 80° will not be accepted.
- 5. SABIC reserves the right to investigate independently the cause of any failure.
- 6. If a claim under this limited written warranty is justified, SABIC will provide the purchaser with replacement material free of charge in accordance with the following schedule:

Orig. Purchase Date	Material Replacement
in 1 <sup>st</sup> year	100%
in 2 <sup>nd</sup> year	75%
in 3 <sup>rd</sup> year	50%

If replacement material cannot be provided within a reasonable period of time, SABIC may opt to refund the original purchase price paid to SABIC, or a portion thereof, in accordance with the above schedule.

- 7. This limited written warranty shall be SABIC sole liability and customer's exclusive remedy for the products and all other claims for damages are excluded. The limited written warranty is in lieu of all other warranties (except of title), written or oral, statutory, express or implied, including any warranty of merchantability or fitness of purpose.
- 8. This three (3) year limited written warranty shall be governed by the laws of the Netherlands.
- This warranty has been issued on February 28<sup>th</sup>
  2003 and is restricted to material sold by SABIC
  after such date and supersedes all previously issued
  warranties for the products mentioned above.
